In accordance with 4 CMC Division 7, Section 7112, I am pleased to present the 2012 Annual Report of the Insurance Commissioner.


This report, which we hope you find useful, includes a listing of admitted insurers and a summary of insurance business transacted in the CNMI from all admitted alien, domestic and foreign carriers during the 2012 calendar year.

During the reported year, the Office of the Insurance Commissioner licensed and regulated two (2) alien carriers, sixteen (16) domestic carriers and forty-three (43) foreign carriers. No new Certificate of Authority (COA) was issued for alien insurer. Two (2) new COA were issued to the following admitted foreign companies, Pacific Employers Insurance Company and Liberty Mutual Insurance Company. No new COA was issued for domestic insurer but authority was granted for withdrawal of Harbor Insurance Company, Limited.

Direct premiums written for Property and Casualty experienced a 6% decrease from \$21.3 million to \$20.03 million. Direct losses incurred increased however by 26.6% from \$5.9 million in 2011 to \$7.5 million in 2012.

## **Priorities of the Office of the Insurance Commissioner for Years 2012 to 2016**

The Office of the Insurance Commissioner (OIC) is poised to actively follow-through on the promulgation of laws or rules and regulations on the recommended priorities. Through the National Association of Insurance Commissioner (NAIC) membership and passage of CNMI Public Law 17-28, "To amend 4 CMC § 5611(d) to establish a revolving fund to pay for the membership dues..." the OIC has been actively engaging the NAIC with resource support on the overall insurance regulatory activity of the OIC as well as other key areas. As the OIC is limited with a single staff aside from the insurance commissioner, the OIC intends to request for more personnel and funding to better equip the OIC with proper personnel and institutional insurance regulatory expertise. The OIC highly recommends the following priorities: Capacity and Resources, Regulatory Practices and Procedures, Authorization on Solvency and Financial Examinations, review and applicability of the Affordable Care Act in the CNMI as a U.S. Territory, and an accreditation review. These priorities will respond to the need for solvency review and financial examination of insurance carriers, promote transparency to consumers, and better services to both insurers and the public.

The OIC intends to initiate communication with NAIC to access technical assistance for capacity and resource enhancement as well as review current regulatory practices and statutes of the CNMI to initiate any form of pre-preliminary accreditation review of the CNMI OIC. An accreditation will standardize the regulatory practices and solvency review of all insurance carriers in the CNMI – relative to the size, culture, and geography of our economic environment, and bringing transparency to the consumers. Overall, the OIC will gain confidence from other States, Territories, or jurisdictions, and will bring the OIC into the present and prepare for a more transparent regulatory practices and supporting economic growth and expansion. As the accreditation will be a long process, the priorities may be occurring simultaneously with the overall intention of realigning the current regulatory practices or toleration of the CNMI OIC. Target date for an NAIC preliminary accreditation review should occur no later than year 2016.
